

## Sample Ashanti Sales Contract / Health Guarantee:

The purpose of this contract is to protect the Buyer, the Seller, and the cat or kitten described below:

This cat/kitten is sold as a  1) Breeder with Show Potential;  2) Breeder;  3) Companion;  4) Retired.

The purchase price of this cat/kitten is  euros, due on day of pick up.

If purchased as a Companion, Buyer agrees to neuter or spay this kitten between the age of 4 and 9 months.

Registration papers will be transferred into Buyer's name upon receipt of full payment, with the exception of kittens sold as Companions, in which case the papers will be transferred when the kitten has been spayed or neutered and proof of the spay or neutering has been received by the Seller.

**Health Guarantee:** *Each cat/kitten is guaranteed for seven days after the animal has been received by the Buyer. It is the responsibility of the Buyer to take the animal to a veterinarian within seven days of receipt for a thorough examination. If the vet identifies a problem, the Buyer must contact the Seller immediately, if the animal cannot be cured, it must be returned to the Seller and the Seller will have the right to either replace the animal with another animal of equal value or to refund the purchase price to the Buyer. If the animal can be cured, the Seller will extend the guarantee period for the length of time needed for the animal to be pronounced healthy by the veterinarian. The cost of the veterinarian is the Buyer's responsibility. There is no fertility guarantee on kittens, unless specifically stated below under "Additional Comments".*

*The Seller will not replace or make refund for any cat/kitten which has not received adequate and appropriate care from it's new owner. It is the responsibility of the Buyer to provide immediate veterinary care to any animal showing signs of illness or distress and failure to do so will render any guarantee null and void. Under no circumstances is a kitten to be destroyed prior to notification by the Buyer to the Seller. Any kitten for which the Buyer expects replacement or refund must be returned to the Seller, so that the identity of the kitten can be verified.*

Additional Comments:

**Shipping:** The Seller highly recommends that animals be picked up in person. Where that is not possible, the Seller will arrange the best flight connections and carrier for shipments, giving preference to counter to counter shipments, where available. Kittens will not be shipped prior to 12 weeks of age. The Buyer or his/her representative must be present to pick up the animal upon arrival, and failure to do so will render the above Health Guarantee null and void. All costs for shipping are the Buyer's responsibility and must be paid prior to the animal being shipped. Any ill effects due solely to shipping or shipping stress will be the Buyer's responsibility. The Seller has the right to delay shipping in order to avoid poor weather conditions.
